# 6. Additional Clauses / Conditions:

LINEUP - Delivering performances from a dynamic set list that keeps pace with today's pop charts, creator/producer Scott Bradlee handpicks musicians and vocalists from an ever-growing, rotating collective of talent (all performers being interchangeable including Scott Bradlee), with each member bringing something unique to the party, Nothing here shall guarantee the appearance of any individual performers including Scott Bradlee.

THIRD PARTY TICKETING - Artist shall be entitled to implement third party VIP ticketing , which may include (without limitation) an Artist meet and greet. 100% of the applicable lift (above the regular ticket price) shall be solely retained by VIP Company /Artist. VIP Company will cover any expenses associated with the VIP program.

RIDER REQUIREMENTS - The Artist Rider is an integral part of this agreement. Purchaser shall provide and pay for all items contained therein and fully comply with all provisions thereof.

RAIN OR SHINE/INCLEMENT WEATHER - If Artist's performance is cancelled due to weather conditions, Artist shall be paid the full quarantee.

CANCELLATION - Purchaser agrees that Artist has the right to cancel its performance with no liability by giving written notice to

Purchaser at least thirty (30) days prior to Artist's performance date listed herein.

TICKET COUNTS - Purchaser shall provide ICM with updated and accurate ticket counts and manifest (when requested) within 24 hours of Artist's request. Automated ticket counts may be emailed to ticketcounts@icmpartners.com

BILLING - All Artist billing for the performance, including, without limitation, font size and positioning shall be subject to Artist's prior written approval, and Purchaser shall not announce Artist's performance prior to obtaining such approval. This provision is a material provision of this agreement.

ADVERTISING/PROMOTION - All advertising, promotion and/or publicity (including, without limitation, print/radio/Internet/TV) is subject to Artist's prior written approval.

PRODUCTION - Purchaser to provide and pay for first class sound & lights, monitors, staging, and production, all per Artist specifications.

HOSPITALITY/CATERING - Purchaser to provide and pay for hospitality and catering, per Artist specifications at least 7 days before the performance.

IMMIGRATION - Purchaser is not responsible for procuring and paying for, at no cost to Artist, any work permits and/or visas required for the engagement.

MERCHANDISE - Artist to retain 100% of the proceeds of Artist merchandise (all goods) - Artist sells.

PROJECT ACTIVITIES DETAILS - Music workshop with students from local music school (their goal will be to conduct a jazz version of Slovak pop song, which they will record as a video)

- University students would conduct interviews with band members choosing a social/cultural topic of their choices (the goal is to create a short publication with reflections of young people having had a chance to talk to PMJ members). This will be further distributed to local schools as a material depicting views and positions of young people here in Prešov, where possibilities for growth and success are rather difficult. We want to show PMJ as an example of how you can by doing a quality work grow from your livingroom to large stages around the world.
- There will be a small questionnaire for all spectators asking them to fill out their feedback on the concert. The goal is to help us understand the impact the concert had on local people, map where the spectators come from, and other topics in order to conduct similar shows in the future.
- For the purpose of project activities, we would kindly ask PMJ members to be with us for at least 2 hours. We will make sure, it will
